### Minutes of the Board of Directors

Friday, July 16, 2021 Venue: Gulf Coast Bird Observatory

The meeting was called to order at 1:02 pm by President Lisa Myers

The **Agenda** was accepted.

**Minutes** for the May 14, 2021 Meeting of the Board of Directors, and the April 30, 2021 Special Meeting of the Board were unanimously approved after a motion by Mickey and a second by Phil.

**E-mail Motions:** Two motions were made and approved during the interim between the May 14<sup>th</sup> meeting of the board and today:

- "The FOBWR board approves the expenditure of \$402.00 for the printing of 1,000 trifold pamphlets that promote the use of refuge trails. Funds will come from general revenues" passed with 9 yeas and 2 no responses.
- "The FOBWR board authorizes applying for a \$78,000 reimbursement grant from the US Fish and Wildlife Service for herbicide enhancement of habitats of Black Rails, Mottled Ducks and other birds on the Brazoria and San Bernard National Wildlife Refuges. The grant would authorize an administration fee of two percent of the grant." passed with 9 yeas and 2 no responses.

## **Discovery and Land Acquisition:** Mike Lange reported that:

- An appraisal of \$106,000 was received for the ten-acre Poole Tract on corner of FM 2918 and CR306. The FOBWR \$10,000 grant from the Trull Foundation will be used as part of the purchase funding.
- At the end of August, the FWS will close on the purchase of 250 acres of the Speers tract that adjoins the Speers
  conservation easement donated to refuge in 2005. This property is a wonderful wetlands frontage on Oyster
  Creek.
- Funding sources are lining up for the 50% match (~\$679k) required to for the \$1,375 million grant from the Knobloch Foundation; all going toward the purchase of the 4,628-acre Peach Creek Forest (a.k.a. McNeil) Tract. NFWF would pledge \$255k from a migration account and another sum from NFWF Acres for America fund. The Brown Foundation has pledged about \$200k. The Mitchell and Hershey foundations are willing, if needed, to supply the remaining ~\$206k.
- Purchase of the 5,755-acre Kbar Ranch is progressing with the Department of Agriculture NRCS approving
  funding of over half of the cost of purchase and restoration under their wetland reserve easement program.
  This property, which adjoins the Bid Pond Unit, is presently only about one third forested.
- The NAWCA grant for \$2 million has been approved; this will allow purchase of tracts in the Columbia Bottomlands.
- The \$35,000 Damuth Foundation grant has been approved.

## **Grants and Projects:**

• FOBWR has been awarded the \$78,000 Coastal Solutions cooperative agreement, "Enhancement of Black Rail and Mottled Duck Habitat at Texas Mid-coast Refuge Complex". This is a reimbursement grant that will be managed by Woody Woodrow as project officer. It consists of arial herbicide spraying of woody vegetation in targeted areas, which will likely occur in the spring and summer of 2022. Regina will create an account to receive reimbursement from the FWS program.

Contract with Ernest Cook: Marty moved that "The FOBWR board approves a Consultant Agreement with Ernest Cook, modified to require approval by the FOBWR treasurer of expenses over \$200, and to cover his activity relating to the Columbia Bottomlands Forest." The motion was seconded by Kim and unanimously approved.

# Refuge Update: Jennifer

- Beginning August 15<sup>th</sup>, Ivy Road south of Bobcat Woods will be closed for about three weeks while culvert structures are installed to replace low water crossing. The task is to be completed before the opening of teal season mid-September.
- LyondellBasell, Chocolate Bayou, will be holding a volunteer day at the Brazoria NWR on September 19<sup>th</sup>; 50 to 75 volunteers are expected to participate in a half-day cleanup. Jennifer will offer the support of FOBWR to supply food and beverage.
- Considerable progress has been made in the eradication of Apple Snails from Smith Lake in Hudson Woods, due to two members of the American Conservation Experience (Ethan and Will) and Friends volunteers.
- Concept signs for the Cedar Lake Plantation Trail have been send to a vendor, with final drafts expected mid-July.
- Signs for Big Slough Trail are being made and should be received in August. Tom will provide an updated placement map to Oron.
- Jennifer, Tom, and Lisa are designing signs for Cannan Bend, including six, 2'X3' signs for the kiosk.
- Efforts have resumed to expand Big Boggy NWR, targeted about 20,000 acres from the adjoining Hawkins ranch.
- Jennifer has asked that FOBWR provide public comment to the US Army Corps of Engineers plan, to be published
  in August, to modify the Cowtrap Lakes area for enhanced protection from hurricanes. Concern is the ecological
  impact on the SBNWR and insurance that refuge boundaries will be protected and that the proposed shallow
  dredging will have minimal damage on oyster reefs. The complex would also prefer that spoilage be spread in a
  thin layer rather than mounding.
- The FWS is targeting the first of October to be fully open to pre-Covid status, with partial opening occurring in the interim. This will allow Refuge Saturday events.
- A workday is scheduled at the Discovery Center for next Wednesday, July 21<sup>st</sup>.

**New Friends Reporting Requirements**. The impact of the new Friends Policy protocol on Friends reporting requirements was reviewed. The financial part of the report is to be based on IRS Form 990 data, which is typically not available until May of the following year. The protocol also requires an annual budget. Marty will forward the full policy to all board members.

### Monthly Refuge Walk:

• The July kayak tour will be postponed to the fall because of the summer heat.

**Financial update:** Treasurer Regina Tippett reviewed the June, 2021 Financial Statement (attached at the end of these minutes), noting that may final payment was made on our Cedar Lake grant. Since our account at TDCEU is down to \$78k, Regina will transfer \$50k from our Merrill Lynch account to TDCEU; this will also lower the funds at Merrill Lynch to under the insured upper boundary of \$250k.

Regina expressed concern over spending of money from our fourth and fifth Houston Endowment grants on activity in geographic areas not specifically designated in the grants, i.e., outside of Brazoria and Fort Bend Counties. The grants are intended to support pre-purchase discovery research on lands in the Columbia Bottomlands Forest; such property extends beyond Brazoria and Fort Bend Counts into adjoining Wharton and Matagorda Counties. Neither the fourth nor the fifth Houston Endowment grants are clear on geographical constraints, although the preceding three such grants constrained reimbursable activity to Brazoria and Fort Bend Counties. Mike Lange will contact Houston Endowment for

clarification of the geographical scope of our current Houston Endowment grants and he will generate a report that shows discovery activity for 2020 in Brazoria and adjoining counties.

**Bylaw update:** Kim presented proposed rewording and clarification of our bylaws, noting that sanction of the changes will be requested at the November meeting of the board. Approval would be requested by the general membership at the January, 2022 board meeting.

Membership: Mickey motioned that "The FOBWR board authorizes the expenditure of up to \$2,500 for the printing of 5,000 membership brochures, with funding to come from operating reserves." Marty seconded the motion, which was unanimously approved. Lisa will update the brochures with our new logo and arrange for the printing.

Outreach: Ruby motioned that "The FOBWR board authorizes the expenditure of up to \$1,000 for the printing of 2,000 refuge trails trifolds, with the cost to be evenly split between the Brazoria and San Bernard McGovern reserves." Kim seconded the motion, which was unanimously approved. Lisa will update the trifold and arrange for the printing.

**Birds of Prey**: Phil is looking for an assistant that can run the raptor programs at schools. He also suggested that we purchase additional table cloths that contain a Friends promotional message. Mickey moved that "The FOBWR board authorizes the expenditure of up to \$150 for the purchase of Friends table cloths, with funding to come from our Birds-of-Prey account." Regina seconded the motion, which passed with unanimous consent.

**Projects:** Oron met with Curtis to begin the process of defining desired repair work needed on the San Bernard Oak Trail; priority would be repairing the last boardwalk section ending at the SB Oak. Heavy rain has prevented a detailed survey. This study is to form the basis for requestion a \$200,000 Recreational Trails grant from the Texas Parks and Wildlife Department.

**TMN Project Fair Submission**: The Texas Master Naturalist Cradle of Texas Chapter has submitted our Bobcat Woods Trail project as their entry for the October TMN state convention. Jennifer has agreed to using a drone to film the trail; the video will become the media of their presentation.

**Action Register**: The updated status of pending items is shown below. New action items are also highlighted in the above text. Items completed since the May board meeting are:

- Cleanup days at the Discovery Center are periodically occurring; it is recommended that the beds in parking lot islands be redone to eliminate weed growth.
- Signs for the Cedar Lake Plantation Trail are being made.

The next board meeting will be on September 10, 2021 at GCBO.

Lisa adjourned the meeting at 4:35PM.
